### **BOARD MEETING**

**APPROVED MINUTES**

#### **Community Reports**

Dave Hoefling gave updates from the County Commissioners meetings and also stated the County Commissioners approved having a plaque made in honor of former County Commissioner, Karen Lipovsky.

The cost incurred for auditor assist is in the October Meeting Minutes. It was discussed to hold

the monthly board meetings at 6:15 p.m. and not 7:15 p.m. It was decided to change the December meeting to 6:15 p.m. for a trial run. The treasurer stated he needed a new printer as his current one is no longer working. A motion made by Linda Bailow/Barb Ferrett to approve the purchase of a new printer for the treasurer. M/C. The supervisor again brought up the subject of a new/up graded sound system. He will look around for a new system and prices.

A motion made by Dave Lawrence/Barb Ferrett to approve and pay the bills. M/C.

A motion made by Jess McClaughry/Dave Lawrence to adjourn the meeting. M/C.
