 - Discussion about setting the date for the 2 meetings. Since this is a renewal of the district, the meetings can be held on the same day.

Savings for only having to do one mailing were also mentioned. For the fire assessment district, the board received most of the feedback by phone and email.
 - Others thought having meetings on 2 separate days would allow more people to attend.

 - It is a renewal of current rates, so NO increase in taxes.
 - The funds are needed to complete critical security features, especially at the elementary school.
